Promotional Giveaway Summary

Use your Lamar Bank and Trust Mastercard Debit Card on or between November 23, 2018 and December 20, 2018 and you could win \$500 cash.

Every time you use your Lamar Bank and Trust Mastercard Debit Card to complete a signature based purchase between November 23, 2018 and December 20, 2018, your name will be entered to win.

Alternative methods of entry for the promotion are described below as no purchase or obligation is necessary to enter or win.

*A Winner will be selected on December 21, 2018 following the promotion period.

Official Rules

NO PURCHASE, TRANSACTION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THIS PROMOTION.

1. How to Enter. There are two ways eligible individuals may enter the Promotion, automatic entry, and by US mail.

- a) Automatic Entry. Every time you make a purchase using your Lamar Bank and Trust Mastercard Debit Card, your name will be entered to win. Purchases of goods must be at a participating merchant location in the United States. Your account must be in good standing, and the entry from your purchase must post on or during the Entry Period.
- b) Entry without purchase or obligation by US Mail. You may enter by hand-printing your name, address, city, state, ZIP code, and daytime and evening telephone numbers (including area code) on a 3" X 5" card, and mailing the card via US mail, in a #10 envelope with postage affixed, to: Lamar Bank and Trust PO Box 190 Lamar MO 64759 Attn: Holiday Mastercard Giveaway. Each mail-in entry will count as one entry into the drawing. Mail-in entries must be postmarked on or after November 23, 2018 and must be received on or by December 20, 2018 in order to be eligible. You are limited to one entry per day and each mail-in entry must be hand written and mailed in a separate, postmarked stamped envelope. 3. Eligible Mastercard Debit Cards. Only Mastercard Debit Cards issued by Lamar Bank and Trust are eligible. Only signature based (credit) purchases qualify (PIN purchases, ATM transactions, and returns do not apply) for the promotion.

4. Eligible Entrants. The Promotion will be open to all who have submitted Promotion entries as described above and who are legal residents of the United States of America and who are eighteen years of age or older as of the date of entry; The following persons are also not eligible to enter the Promotion: (a) Employees of each Sponsor, and their subsidiaries and affiliates, and (b) any immediate family members of any such employee, whether living in the same household or not, and (c) anyone living in the same household, whether related or not.
